The Mission Statement of INTERNATIONAL COLLEGE ALBENA (ICA) states that the College is committed to providing high quality professional education within an international environment of advanced knowledge society, and highly competitive and dynamic knowledge-based economy in the world.

STRATEGIC OBJECTIVES The ICA has defined its strategic goals and has designed its policy with commitment to addressing the increasing role of the higher education institutions in the new realms and ensuring European dimensions, compatibility and comparability of degree courses and training modules, whilst taking full respect of the national diversities. Focus is placed on promoting entrepreneurial spirit, as well as language, IT and communication competencies which will raise the employability of the school graduates. We aim at educating highly qualified specialists that will meet the requirements of business and face the challenges of the labour market. Intercultural dialogue and personal fulfillment are fully encouraged. Achieving recognition of the quality of ICA degrees allows the graduates to continue their studies for further degrees in reputable European universities.

Since its foundation ICA has adopted a policy of protection of individual rights, and in all documents and papers has made commitment to combat inequality, racism, xenophobia and exclusion of socially disadvantaged groups. Students are enrolled and staff is employed regardless of gender, nationality, religion and disabilities.

Quality of academic mobility activities:

What kind of specific measures are implemented in the institution to ensure high quality in academic mobility activities?

Since its foundation the College had adopted a strict policy for academic recognition of student mobilities, which after one year trial period, in 2006/2007 was fully replaced by ECTS GRADING SYSTEM. The credits awarded to incoming students are listed in Academic Transcript issued by ICA. Credits awarded from partner universities to outgoing students are recognized and listed in the students' dossiers and in the European Diploma Supplement. Information on ICA curricula, facilities and services is provided in ERASMUS INFORMATION PACKAGE, distributed in hard copy to all partner universities and available in a downloadable format on the College website. International office is responsible for Erasmus campaigns and counseling of outgoing students. Erasmus students are assisted in: choosing an exchange program adequate to the individual program of study, as well as their needs and requirements; contacting the partner school Erasmus coordinator; organizing the travel and accommodation; training in cultural differences and if needed searching for additional funding.

ICA offers three-year programs in English language thus providing incoming students with a constant variety of modules to choose from in the fields of Hospitality, Tourism and Business studies. Tutoring is provided by the course

coordinators.

The "buddy system" proves efficient for the integration of the incoming students. International office trainees are responsible for meeting the incoming student, accommodating him/her, organizing a welcome event and keeping in contact during his/her stay. Students have full and free access to library, computer lab and training facilities. ICA has a tradition in preparatory course in English and intensive course in Bulgarian are provided upon request. Staff mobility is a priority and is supported by assistance in arranging the visity lecturing activities, travel, accommodation, additional financing. The mobility is acknowledged as part of the individual's career.

Quality of student placement activities:

What kind of specific measures are implemented to ensure high quality in student placements? Give details on how the work-programme and the placement agreement are prepared and implemented. Student placements are an integral and compulsory part of the curricula. The organization, monitoring and evaluation of placements are responsibility of the Placements Department, consisting of tutors and instructors who are also in charge of practices in the school training facilities and laboratories. The high quality of placements is ensured by specially designed INDUSTRIAL PLACEMENT module books, manuals, models of progress reports, model agreements with enterprises, employer's evaluation reports and other supporting documents. ICA has a tradition in student placements with operational and managerial exposure in the fields of tourism, hotel, catering, production enterprises, NGOs and others. ICA successfully finalised one project in Leonardo da Vinci Il/student mobilities and is currently working on a second one for a total of 30 beneficiaries. The LdV projects, as well the partnership with European universities enabled ICA to develop a vast network of placement opportunities in the Netherlands, Cyprus, Greece, Portugal, UK, France and others. ICA as an institution signs yearly agreements for student placements with enterprises. The specific work-programme, designed by ICA team in cooperation with the enterprise is the core part of the agreement. Agreements ensure that students have a statute of trainees, their traineeship meet all requirements of the host country, adequate accommodation is provided, as well as insurance, meals and uniforms. The enterprises are responsible for monitoring and evaluation, regular reporting to ICA on the student progress and the measures taken in cases of emergency. An ICA representative executes monitoring by personal visit once for the three-month placements and twice for 6-month placements.

The recognition of the placement period is done by progress reports and a final report, submitted and orally defended, and evaluated by jury. Each placement period is awarded 7,5 ECTS or a total of 30 credits for the whole

study program.
